At any time up to and including the distribution of a grant, the Foundation may: (i) deny or withhold approval of any grant application; (ii) withdraw its preliminary approval of any grant application; (iii) refuse to distribute any grant, if, in its complete and unfettered discretion, the Foundation determines that the award does not meet any of its requirements, and/or if the Foundation determines that:

Appropriate documentation has not been provided;

- There are insufficient funds available;
- The criteria or awards are discriminatory or otherwise violate any law; or,
- Distributing the award could not be in the best interests of the Foundation, or might cause harm, including but not limited to financial, legal, material, or harm to reputation, to the Foundation.

Other conditions which the 1832 Foundation Board of Directors, Executive Committee or President may at their sole discretion require, shall also apply to all grants.
